



As Executive Director, Derek Anderson provides chief executive oversight of the day-to-day operations and strategic direction of Northern Westchester Hospital. He assumed the position in January 2020 after steadily progressing through the ranks at Northwell Health.

Mr. Anderson joined Northwell in 2009 and held various positions in operations before he was named associate executive director in 2016. In this role, he had oversight for the daily operations of the 850-bed quaternary campus of North Shore University Hospital in Manhasset, New York. He was also responsible for the planning and execution of approximately \$740 million in capital projects during his tenure, including a \$625 million surgical pavilion expansion project, which opened in February of 2024. Recently at Northern Westchester Hospital, leading initiatives to successfully grow the organization in quality and state rankings, improving financial performance, launching a cardiac catheterization and electrophysiology program, and investments in community partnerships and health programs.

Mr. Anderson has published and presented nationally about hospital management. In 2014, was the recipient of the President's Award for Innovation, a Northwell-wide recognition, and received the Best Management Innovation Award from the American College of Healthcare Executives' (ACHE) annual Congress in 2012. He serves as the Chair of the Healthcare Consortium of the Westchester County Association, where he also sits on the Board and is a member of the Executive Committee. In addition, he is the Vice-Chair of the Board at Northern Metropolitan Hospital Association.

Prior to Northwell, Mr. Anderson worked in the Department of Surgery at Intermountain Healthcare, based in Salt Lake City, Utah. 


Kham Ali was born in London but grew up on the beach in South Jersey where he witnessed his parents pursue the classic American Dream via hard work, determination, and creativity. Kham was along for the ride and learned many valuable lessons as he would spend long hours in the family bakery perfecting croissants, danishes, and palmiers while serving customers. This work ethic led him to a merit scholarship at George Washington University where he completed a dual BS program and eventually medical school. He had a short stint in be-

tween undergrad and medical school with the Department of Defense in the neuro defense division as an analytical chemist. With a passion for policy and improvement of healthcare systems, he took a year off of medical school to pursue his MBA at the University of Cambridge in the UK. There he completed projects for the NHS and multinational consulting firms. He begrudgingly gave up a consulting position in London and returned to DC to finish out medical school and eventually meandered to the field of Emergency Medicine where he fell back in love with patient care. Forever in search of opportunities to better serve his community on a larger scale, he decided to pursue an MPH at Harvard during which he started multiple impactful initiatives including a digital health equity program aimed at reducing avoidable visits by the homeless population to ERs. He graduated from the program this spring while simultaneously assuming the office of President. He hopes to build on his education and accomplishment in order to impact meaningful change across at risk populations, healthcare payer system inequities, and healthcare technology infrastructure.

Peter Acker has been a practicing pediatrician in New York and Connecticut for 36 years. He is the past chairman of pediatrics at Greenwich Hospital. He received his MD degree from Sackler School of Medicine in 1982 and completed a residency in pediatrics and fellowship in ambulatory pediatrics both at the New York University/Bellevue Medical Center. Future of Medicine Award Winner: Catherine Chun—Ardsley High School Medicine & Health Services



A senior at Ardsley High School, Catherine is passionate about the intersections of biology, technology, and global health. Through her long-term research project on the genetics of inflammatory bowel disease (IBD), which she conducted under the mentorship of Dr. Inga Peter at the Icahn School of Medicine at Mount Sinai, Catherine has gained and shared insights into developing a long-term cure for IBD. Working in a lab and developing this study over the past three years has allowed her to understand and appreciate how research and scientific inquiry can help make a positive impact on the scientific community. This fall, Catherine will be attending Dartmouth College, where she plans on studying Biology and Computer Science on a premedical track.

Abstract

Elucidating the Genetics of Inflammatory Bowel Disease: The Effects of Risk LRRK2 Mutations on the Bacterial Gut Microbiome

Inflammatory bowel disease (IBD), characterized by chronic inflammation of the gastrointestinal tract, is an autoimmune disease impacting 6 million individuals worldwide. A mutation in the Leucine-Rich Repeat Kinase 2 (LRRK2) gene is a riskfactor for disease onset. However, researchers currently don't understand the exact mechanisms by which LRRK2 contributes to IBD, which has consequently slowed the development of LRRK2 inhibition treatments for IBD patients. The goal of this study was to assess how LRRK2 affects one potential LRRK2 mechanism: the gut microbiome, which is established to correlate with severity of IBD. Stool samples were collected from control individuals and case IBD individuals. Then, DNA sequencing was performed, and QIIME microbiome analysis was conducted in R, where LRRK2 carriers and non-carriers were assessed for overall bacterial abundance, alpha diversity, and beta diversity. Ultimately, the microbiome analysis results demonstrated that LRRK2 mutations are associated with decreased gut microbiome diversity, and there exists differential beta diversity between carriers and non-carriers in control and case individuals. Further, replicated analyses in control mice demonstrated similar associations, confirming the potential of mouse models to then develop and test LRRK2 inhibition treatments. The findings of this research are novel in their identification of gut dysbiosis as a specific LRRK2 mechanism in IBD, and propose a promising new avenue for the development of LRRK2 inhibitors to restore gut microbiome diversity as a long-term and universal treatment for IBD patients.

Future of Medicine Award Winner: Richa Patil—Edgemont High School Neuroscience



Project title: Alteration in Macrophage to Neuron Signaling Limits Axonal Regeneration in Diabetes

Mentor: Dr. Dianna E. Willis, Burke Neurological Institute

Abstract:

Diabetes is a chronic metabolic disease, and most patients eventually suffer from a complication called peripheral neuropathy, resulting in altered sensation in distal extremities. There is no treatment, and we do not understand the mechanism(s) that cause peripheral neuropathy. Damaged axons of peripheral nervous system neurons usually have the

capacity to repair themselves following injury; however, this capacity is reduced in diabetes. Previous studies have shown that upon axon damage, ATP is released into the extracellular space, suggesting that purinergic signaling may be an important part of the injury response. We investigated the effect of different adenosine concentrations on dorsal root ganglion (DRG) axon growth to see whether increased levels of adenosine would increase growth for normoglycemic and diabetic axons. We also analyzed the protein levels of the Adenosine A1R receptor and the levels of adenosine before and after injury in both normoglycemic and diabetic conditions. In comparison to normoglycemic DRGs, it was found that axonal growth for diabetic DRG axons was both decreased and did not respond to elevated adenosine levels. The levels of the A1R receptor protein showed no difference between the normoglycemic and diabetic conditions, suggesting that changes in A1R receptor levels do not cause the reduction in axon growth. Adenosine levels in DRG tissue from normoglycemic animals show a non-significant increase following injury. Future studies would entail increasing the sample size of mice to better power the results, and further increasing adenosine concentration levels to determine the maximal axon growth that can be induced.

Future Goals:

In the future, I would like to continue exploring the field of neuroscience. In college, I hope to major in neuroscience on a pre-med track. I want to continue doing research in college, but I would also like to gain clinical experience working directly with patients. Hopefully, I will then be able to connect my work as a researcher with my experience working with patients. Aside from being passionate about science, I am a cellist and black belt in Taekwondo. I also enjoy photography and traveling.

Future of Medicine Award Winner: Massimo Reali—Harrison High School Medicine & Health Sciences



I have been involved in the Harrison Science Research program for two years. I joined science research because I have always been interested in medicine and I wanted the opportunity to explore ideas and methods beyond what was taught in the classroom. During my childhood, my father was diagnosed with stage four colon cancer, and was only expected to live for another ten years. I observed the side-effects and limitations of chemotherapeutic options for Colon Cancer patients firsthand. I hope to transform treatment options and drug delivery systems to mitigate these side-effects, fueling my passion for researching PLGA-PEG based nanoparticles loaded with the platinum-based chemotherapeutic drug oxaliplatin and folic acid. This study determined if nanoparticles improved the effectiveness and efficiency of drug delivery systems in the tumor microenvironment. Working with Dr. Jennie Williams and Dr. Justin Fang at Stony Brook University, I was able to utilize double emulsion methods to formulate nanoparticles, UV spectrophotometer to quantify

the drug content of oxaliplatin, and an MTT Assay to measure the proliferation rates of HCT116 and HT29 cell lines. The sizing between nanoparticles with folic acid was significant, leading to future research of evaluating the effectiveness of PLGA-PEG nanoparticles on cell lines derived from different ethnicities, and quantifying folic acid concentrations through Western Blot and Flow Cytometry. Future plans include working in a laboratory setting throughout my college career, as well as majoring in biomedical engineering / biomedical sciences.

Abstract

Oxaliplatin is a platinum-based chemotherapy drug facilitated in colon cancer cell lines used to produce high proliferation rates of cancer cells within the tumor microenvironment.

Nanocarriers are small agents that can encapsulate chemotherapy drugs to effectively deliver a drug to the designated tumor site, to improve drug delivery efficiency, effectiveness and selectivity. The purpose of this study was to determine if the use of PLGA-PEG nanoparticles decorated with folic acid quantifies the effectiveness of the platinum based drug oxaliplatin in colon cancer HT-29 and HCT-116 cell lines making drug delivery more efficient and effective to a targeted area. The methodology consisted of three different steps: 1.PLGA-PEG nanoparticles were formulated using singleemulsion methods 2. A calibration curve of oxaliplatin was constructed at different wavelengths using a phenanthroline assay to quantify the drug 3. XTT-Assay was used to measure colorimetric viability of the HCT-116 and HT-29 cell lines to determine the effectiveness of PLGA-PEG based nanoparticles loaded with oxaliplatin and folic acid. Results showed that under SEM Imaging, the nanoparticle group with oxaliplatin and folic acid was significantly smaller than the other samples (p < 0.05), meaning that these particles had a higher chance of reaching the tumor site and were more targeted. This showed promise as smaller nanoparticles are able to pass through more efficiently and effectively, while targeting the tumor site itself rather than spreading to key lymphatic systems and organs in the body, However, no color change was observed in the HCT-116 or HT-29 cell lines in the XTT colorimetric assay, indicating that the cells were not treated by any of the four nanoparticle groups. More research is needed to refine the encapsulation techniques of PLGA-PEG nanoparticles, improving the ability of these nanoparticles to target the tumor site.
